

HKHS Community ESG Programme Terms and Conditions

1. HKHS Community ESG Programme ("The Event") is scheduled to take place from 0:00 am on 1 July 2023, to 11:59 pm Hong Kong time on 31 December 2023 (hereafter referred to as the "Event Period").
2. The Event is organised by The Hong Kong Housing Society ("HKHS") and is open to residents of designated housing estates of the HKHS, HKHS' staff, and committee members to participate. However, the grand prize is exclusively applicable to residents of designated housing estates of HKHS (i.e. HKHS' staff and his/her relatives including parents, children and spouse are ineligible for the grand prize).
3. The final score for each participant of the Event will be determined by the individual carbon emission results of the participants (calculation based on the accumulative reduction in carbon emission results). Those who reside in the designated HKHS housing estates who have reduced the most carbon emission during the Event Period will win the grand prize. Should there be more than one participating resident attain the highest final score, the participating resident who achieve the highest final score first in time will be declared as the winner.
4. Each household is limited to a maximum of three registered users.
5. Upon registration as a member of "My Community," participants hereby acknowledge that they have read and agreed to be bound by all terms and conditions of the Event.
6. Any illegal or fraudulent behaviour by a participant shall disqualify the participant from winning the prizes.
7. Prizes are non-transferable, and winners cannot exchange or redeem them for cash. HKHS is not responsible for possible changes in prize value.
8. All prizes are non-returnable and non-exchangeable for cash. No replacement will be made if the prize is lost or stolen upon receipt of the prize.

20. In the event of any disputes, the decision of HKHS shall be final and conclusive, and binding on all participants.
